

SUMMARY OF THE BUSINESS -

Convert this salon with huge growth potential to a booth rental system and expand spa services with the 4 existing spa rooms. Currently outfitted with 9 stations, employees include 6 stylists, 1 massage therapist, 1 skin care professional and 2 receptionists. The immediate area has a higher average income than 93% of Nebraska, with a 52.3% female population. Nearly 50,000 cars pass by this location each day, making expansion potential a great possibility.

Currently the employees are part of a payroll, but a new owner could convert to a booth rental system. With

all 9 stations rented out at \$400/week, and the 4 spa rooms rented to estheticians or masseurs at \$600/week, a new owner could see rental income of \$24,000/month, minus expenses. Current payroll expenses average over \$20,000 per month, and a new owner could consider keeping current employees on payroll and renting out the remaining booths/rooms.

At 3,234 sq. ft., the salon services clients in haircuts, color, wraps, massages, nails, waxing, tanning, skin treatments and makeup. Spa services include a hydro tub used for therapeutic services. While there are roughly 6 nearby salons, none of them offer the extensive services or luxe found at this one. It is also the only salon/spa within a well-trafficked strip mall.

Growth potential abounds in hiring 5 more stylists or converting the salon & spa to a booth rental system. The 4 spa rooms can be rented out to estheticians or masseurs to expand spa services, or 1 or 2 can be converted into stylist suites for a higher rent.

Cash Flow Analysis

Pro Forma by Number of Renters

Currently all employees are paid a salary and receive a commission percentage based on tenure. As with most other salons, a booth rental system is a great alternative as a way to ensure income and to encourage upselling of retail products. There are currently 6 stylists, 1 skin care specialist and 1 massage therapist employed.

Monthly Income 6 stylists renting at \$400/week = \$9,600 1 skin specialist renting at \$400/week = \$1,600 <u>1 massage therapist renting at \$500/week = \$2,000</u> Total rent of \$13,200/month *Retail Commissions at 20%*

\$2,640 in estimated monthly retail commission

Monthly Expenses

1 FT receptionist at \$11/hour = \$1,760/month

Rent of \$5,584

Utilities (OPPD/MUD) of \$928/month (\$11,136/year)

Licensing & insurance of \$249/month (\$2,994/year)

Total expenses of \$8,521/month

Monthly Profit of \$7,319 (\$87,828/year)

There are currently 9 commissioned chairs and 4 rooms for spa treatments. A new owner could add more chairs (up to 5), or convert some of the 4 rooms into stylist suites or rent them all to dedicated spa professionals.

9 stylists renting at \$400/week = \$14,400 4 spa rooms rented at \$600/week = \$9,600 Total rent of \$24,000/month

Retail Commissions at 20% \$4,800 in estimated monthly retail commission


Monthly Profit of \$20,279 (\$243,348)

Current owner spends an average of \$20,375 per month in payroll expenses, in addition to the Projected Monthly Expenses shown above.


Sales Statistics

- Over 5,400 guests were serviced in 2016

3,234 sq. ft. - Currently there are 6 stylists, 1 esthetician and 1 massage therapist with room for the addition of 5 more stylist stations. The spa area is not being fully utilized, and with some refurbishment or rearranging, there are 4 rooms that may be rented out to more estheticians, masseurs or additional services.

Employees

- Service employees are paid on a commission schedule based on their tenure
 - Stylist 1 60% (8 years manager)
 - Stylist 2 54% (7 years)
 - Stylist 3 54% (7 years)
 - Stylist 4 54% *(5 years)*
 - Stylist 5 48% *(2 years)*
 - Stylist 6 48% *(1 year)*
 - Massage Therapist 50% (1 year)
 - Skin/Esthetician 49% (1.5 years)
- Receptionists
 - Full-time \$11/hour (2 years)
 - Part-time \$9.80/hour (1.5 years)
- All stylists, massage therapists and skin care specialists are employees possible to restructure the salon to make it a booth rental system
- The manager (stylist 1) handles the day-to-day operations, as the owner is an out-of-state investor
